General Meeting Minutes – 11/26/2025

After the votes to elect the president were counted and recorded the Secretary reported that Ed Constantino had received 22 votes (21 by ballot, 1 by absentee voting system) and Jim McClintock had received 64 votes (54 by ballot, 10 by absentee voting system) and then made the following motion.

**As the Secretary and as a regular member of the men' league I make a motion that we accept the vote count as reported and elect Jim McClintock as the president of the BBB Men's Golf League for the 2026 term.**

**Secretary's Report** – The last General meeting was held on 10/22/25 and the minutes of that meeting were posted on our website and the Secretary asked the membership if they would accept them as posted. **Tom Felke made a motion to accept these as posted and Emil Pizzulo seconded the motion. The motion was unanimously approved.**

**Treasurers Report** – Hugh reported that we had \$2,636.49 as our 10/31 balance and the details for October are posted in the men's league binder.

**Presidents Report** – The President reported that the Board has approved an increase from \$30 to \$35 for annual membership starting 1/1/26. This is to cover increased cost of food, drink and other expenses rather than push up the cost of our events.

He reported that the new cutoff for all games and competitions, food, etc will now be Saturday at 3 pm. He noted that as the new tournament chairman starting next year this will be more strictly enforced.

The handicap committee was formed within the board to review scores and make sure there is fair and equal competition between members.

Our weather policy is whenever we have cart path only we use lift, clean and place in the fairway only. If the sand traps are unplayable we drop the ball either beside or behind the hole but no closer to the hole. We hope to have signs made up to place near the first tee in the near future whenever these conditions are being used.

Dave reminded everyone that our cancellation policy is before noon on Monday otherwise you invite a 2 week suspension penalty at the discretion of the committee.

He reminded everyone to keep the scorecards neat and to please add them up.

**Vice Presidents Report** – Herb reported that we have 133 members and he introduced some that were present. The hole-in-one pool is currently at \$760 and is now active again.
